ORDER FOR RELIEF UNDER PENAL CODE §1203.4, §1203.4a, §1203.41, §1203.42	Case Number: Driver's License: Date of Birth:

If this order is granted under the provisions of Penal Code 1203.4 or 1203.4a or 1203.41 or 1203.42:

- The defendant is relieved from all penalties and disabilities resulting from the offense except as provided in Vehicle Code 13555.
- Dismissal of an accusation or information pursuant to this section does not permit a person to own, possess, or have in their custody or control any firearm or prevent their conviction under Chapter 2 (commencing with Section 29800) of Division 9 of Title 4 of Part 6.
- As required by Penal Code section 299(f), this relief does *not* release the defendant from the separate administrative duty to provide specimens, samples or print impressions under the DNA and Forensic Identification Database and Databank Act of 1998 if the defendant was found guilty by a trier of fact, not guilty by reason of insanity, or pled no contest to a qualifying offense as defined in Penal Code section 296(a).
- Dismissal of the conviction does *not* permit a person prohibited from holding public office as a result of that conviction to hold public office.
- Dismissal of the conviction does *not* relieve the defendant from any obligation to register under Penal Code section 290 for misdemeanor convictions.
- For relief granted pursuant to Penal Code §§ 1203.4, 1203.4a and 1203.41, any unexpired criminal protective orders that have been issued by the court shall remain in full effect until expiration or until any further order by the court modifying or terminating the order, despite the dismissal or the granting of conviction record relief, of the underlying accusation or information.

If this order is granted the provisions of Penal Code section 1203.41 additionally apply:

- Dismissal of the conviction does *not* relieve the defendant of the obligation to disclose the conviction in response to any direct question contained in any questionnaire or application for public office, for licensure by any state or local agency, or by a federally recognized tribe, or for contracting with the California State Lottery.
- Relief granted does not make a person who is otherwise ineligible to provide, or receive payment for providing, in-home support services as codified in Penal Code 1203.41(h).
